- 2) Long term road repair & maintenance plan. Discussion of road plan.
- 3) Summary of Discussion points: Dennis talked to Mike Wirth and was told repairs will be finished before the annual meeting and grading will be done once the weather permits. Water trucks will be used in the repair areas to help with compacting the repairs that will be done on Arrow drive, Beaver slide, Rocky road, Spring drive and Eagle Canyon road. Grading should start hopefully by the end of September when moisture is more available to help with the dust. LOA will pay 50% of the cost for the use of the water truck that Mike Wirth will be using while doing the repairs. The extra cost might be up to \$2,500. If Mike Wirth can't get it done, then a new contractor will be called to finish the roads as well as used for future work. The road plan needs to be updated to state which repairs are needed as well as which roads are not gradable due to rocks, but have those added to future repairs once the main roads have been finished. Road committee should be meeting 2-3 times a year to assess any damages that may occur over the seasons. Start putting prices of what projects are costing such as what the bridge will cost to repair and such.

The LOC has been neglected for too many years and no funds have been put back into the community so all repairs are going to be costly.
